SUBMISSION

Impresa Sociale publishes articles, case histories, commentary on policy documents, book reviews and other material relating to social enterprise's constitutive characteristics, organizational models and legal forms, management, development policies, etc. The magazine is in Italian, but writing in English will also be taken into consideration.

To make a submission send the document to the editorial assistant (info@rivistaimpresasociale.it), following the instructions given below.

Guidelines for Authors

Articles

Authors who wish to publish academic articles in *Impresa Sociale* are asked to send the following documents:

presentation letter including:

- title
- full name of author(s)
- abstract: 150-250 words (in Italian and English)
- keywords: 4-6 words that sum up the central theme of the article
- affiliation and address for all authors
- e-mail address and telephone number of the author who will serve as the reference point during the submission phase

article without references

- the article should be sent as a Microsoft Word file and the document should not contain any details relating to the author(s) and/or information that could identify them
- the article can be in Italian or English
- the article must be no longer than 10,000 words

The presentation of an article implies a commitment by the authors to publish it in this journal. During the submission phase the authors must declare if the article has already been published or submitted to another publication. In this case the editors reserve the right to evaluate the legitimacy of the submission to the journal *Impresa Sociale*.

The article submitted for publication will undergo a preliminary blind evaluation by a member of the Editorial Committee to assess the topic's connection with the journal's areas of interest, the presence of any obvious academic shortfalls and whether or not the contribution follows the submission rules.

If the preliminary evaluation is positive, the document will undergo a double-blind peer review. The following review criteria will be assessed: correctness of the methodological approach, expository clarity, new or original contribution to the advancement of studies of the subject, adequacy of the essential bibliography.

The outcome of the evaluation can be acceptance of the text for publication, acceptance dependent on remedial modifications or non-acceptance of the text.

Other texts

There are no specific editorial criteria for the submission of other documents. The authors are asked to send their text as a Microsoft Word file, and to include:

- title
- full name of author(s)

- affiliation and address for all authors
 - document type: case history, commentary on policy document, book review, other
 - e-mail address and telephone number of the author who will serve as the reference point during the submission phase
- The text must be no longer than 7,500 words and can be in Italian or English.

The text will undergo a joint evaluation by the editors and a member of the Co-chief Editor.

Copyright

The authors maintain the rights to their work and grant to the journal the right to first publication of the work, simultaneously licenced under a Creative Commons Licence – Attribution – Noncommercial – No Derivative Works 3.0, which allows others to share the work indicating the intellectual provenance and that it was first published in this journal.

Privacy

Authors permit the use of their names and e-mail addresses in accordance with Italian Law 196 of 30/06/2003.
